ORDINANCE NO. 021-005
DATE OF PASSAGE February 9, 2021

An Ordinance Amending Chapter 37, entitled "Preservation", of the Aurora Code of Ordinances to modify certain portions being Article II, Sec. 37-21 - Creation; members

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the City Council of the City of Aurora has determined that it is necessary and desirable to amend Chapter 37, entitled "Preservation", in order to update and improve certain Sections of said Ordinance to better carry out the purpose and intent of said Ordinance; and

WHEREAS, on January 14, 2021, the Aurora Preservation Commission held a meeting on the amendments to said Ordinance and recommended approval of the amendment attached hereto and incorporated herein and hereinafter referred to as Exhibit "A"; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Aurora, Illinois, as follows:

Section One: That the City Council of the City of Aurora, Illinois finds as fact all of the preamble recitals of this Ordinance.

Section Two: That this Ordinance shall be in full force and effect, and shall be controlling, upon its passage and approval.

Section Three: That all Ordinances or part of Ordinances in conflict herewith are hereby repealed insofar as any conflict exists.

Section Four: That any section, phrase or paragraph of this Ordinance that is construed to be invalid, void or unconstitutional shall not affect the remaining sections, phrases or paragraphs of this Ordinance which shall remain in full force and effect.

Section Five: That Chapter 37, entitled "Preservation" of the Aurora Code of Ordinances, is hereby amended as set forth in Exhibit "A."





Exhibit A

Modifications to Sec. 37-21 – Creation; members

Sec. 37-21, entitled "Creation; members" of Article II of the Aurora Municipal Code

- a) There is created the Aurora Preservation Commission, which shall consist of eleven (11) voting members to be appointed by the mayor with the consent of the city council. Members shall serve for terms of three (3) years which may be extended until the respective successor of each member is appointed. Vacancies shall be filled by appointment for the remainder of any unexpired term. ~~Members may be appointed for no more than two (2) consecutive terms.~~
