## APPLICATION FOR PERMIT PARKING

A parking permit allows you to park ALL DAY in any City Surface Lot of the COLOR you choose. Aside from being able to park in the color of the lot that you purchase, you can also park in lower-hierarchy lots. For example, a gold parking permit also allows you to park in any color lot; silver parking permits also allow parking in bronze and mercury lots, etc. Permits are not valid for on-street parking or parking overnight. A separate Overnight Permit is available. See below for permit rates. NOTE: Permits are billed on a QUARTERLY BASIS.

\*Gold Plus allows parking in the Stolp Island Deck in addition to any City Color Lot. PLEASE NOTE: There is a \$10 deposit for Stolp Deck pass cards and a replacement cost of \$15 for lost/stolen pass cards. Additional vehicles require the purchase of a separate pass card.

\*\*Overnight CBD (Central Business District) permit allows overnight parking between 3am-5am in any City surface lot. It can be combined with a monthly permit for unrestricted parking.

**Parking Rules and Regulations**

1. All permit parking payments must be paid in full (on a calendar quarter basis) prior to the beginning of a new calendar quarter.
2. Amounts billed will be due unless notification of cancellation is received in writing by the Motor Vehicle Parking Systems office. **FOR GARAGE, PASS CARD MUST ALSO BE RETURNED TO OUR OFFICE.** Refunds will be issued on a pro-rated basis (increments of half months) minus a ten dollar (\$10.00) administrative fee for handling the refund.
3. **PERMIT PARKING:** Please park in your assigned color lot or lower. Lot parking is on a first come, first served basis. If the lot you normally park in is full, please park in a **LOT OF THE SAME COLOR HIERARCHY OR BELOW.** If Stoop garage deck is full, you may park in any other City Lot and call 630-256-3580 with any questions or concerns.
4. **OVERNIGHT PARKING:** Permitted with display of an overnight permit in those specific lots and areas which are posted by the Dept. of Motor Vehicle Parking Systems, Monday thru Friday, from 6:00 P.M. thru 7:00 A.M., Saturday after 12:00 noon, and Sunday all day. **PERMIT MUST BE DISPLAYED.**
5. Any change in vehicle make, or change in license number, must be reported by calling the City of Aurora, Motor Vehicle Parking Systems at (630) 256-3580. Failure to do so will result in the issuance of a citation and/or the removal of the vehicle from the lot.
6. **Permits and passcards are not transferable.**
7. For purpose of lot maintenance, you may be requested to park in areas other than the specified parking area by the MVPS department.
8. Unregistered, unlicensed, abandoned, or inoperative vehicles will be removed at owner's expense.
9. Automotive repair work is not permitted on the premises of any lot or parking garage.
10. The City of Aurora reserves the right to cancel or deny renewal of any parking permit to any applicant. Anyone who is in violation of any City Ordinance and has failed to correct the violation within fifteen (15) days of notification will be cancelled. In addition, the City of Aurora reserves the right to CANCEL any GOLD PLUS permit that is not used more than three (3) times in a given month. In this case, a regular GOLD permit will be issued at the same rate or less.
11. The City of Aurora is not responsible for any loss or damage to vehicles or their contents from fire, theft or any other cause.
